## Proclamation

WHEREAS, IN THE PAST, WOMEN IN THE UNITED STATES HAVE BEEN TREATED AS SECOND-CLASS CITIZENS AND HAVE NOT BEEN ENTITLED TO THE FULL RIGHTS AND PRIVILEGES AVAILABLE TO MALE CITIZENS OF THE UNITED STATES; AND

*WHEREAS*, AUGUST 26 IS THE ANNIVERSARY DATE OF THE PASSAGE OF THE  $19^{TH}$  AMENDMENT IN 1920, WHICH GRANTED WOMEN THE RIGHT TO VOTE; AND

*WHEREAS*, THE CONGRESS OF THE UNITED STATES IN 1971 DESIGNATED AUGUST 26 AS WOMEN'S EQUALITY DAY TO SERVE AS A SYMBOL OF THE CONTINUED FIGHT FOR EQUAL RIGHTS; AND

WHEREAS, THE WOMEN OF THE UNITED STATES ARE TO BE SUPPORTED IN THEIR FIGHT FOR EQUALITY AND COMMENDED FOR THEIR ACHIEVEMENTS;

*NOW, THEREFORE, I,* SUSANA MARTINEZ, GOVERNOR OF THE STATE OF NEW MEXICO, DO HEREBY PROCLAIM AUGUST  $26^{TH}$ , 2014 AS

## "WOMEN'S EQUALITY DAY"

THROUGHOUT THE STATE OF NEW MEXICO; AND

- RECOGNIZE THAT THE OBSERVANCE OF WOMEN'S EQUALITY DAY NOT ONLY COMMEMORATES THE PASSAGE OF THE 19<sup>TH</sup> AMENDMENT, BUT ALSO CALLS ATTENTION TO WOMEN'S CONTINUING EFFORTS TOWARD FULL EQUALITY; AND
- AFFIRM THE RIGHT OF WOMEN OF THE UNITED STATES TO ASSEMBLE IN PEACEFUL DEMONSTRATION FOR WOMEN'S RIGHT; AND
- ENDORSE PUBLIC RECOGNITION OF WOMEN'S EQUALITY DAY BY ALL NEW MEXICO RESIDENTS AND VISITORS WITH COMMEMORATIONS OF WOMEN'S PROGRESS AND CONTINUING EFFORTS TOWARD ATTAINING FULL EQUALITY.
